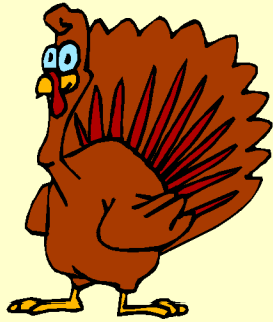

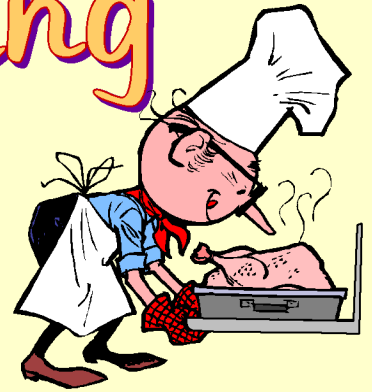

## Minutes



### Call to Order:

Gale Cochran-Smith called to order the business meeting of the Chisholm Trail Art Association (CTAA) at the Chisholm Trail Room at the Wellington State Bank in Bowie at 6pm.

### Roll Call/Minutes/Treasurer's Report:

- a. No minutes were read for the prior meeting which was held on October 9, 2014
- b. Each member present at this meeting signed the guest book in lieu of roll call.
- c. Bank balance as of October 30, 2014 was \$684.66.

### Business:

- a. Jennifer Hammer mentioned that the deadline for items for newsletter be no later than the 25th of the month.

- b. Sharon Brown has graciously offered to host the Christmas party at her home at 6497 FM 1956, Nocona on December 11, 2014 at 5:30 p.m. The club will furnish turkey and Jack Milchanowski will provide the ham. The members are asked to bring side dishes. It was unanimously decided that instead of having a gift exchange, members would voluntarily donate \$20 to the scholarship fund. 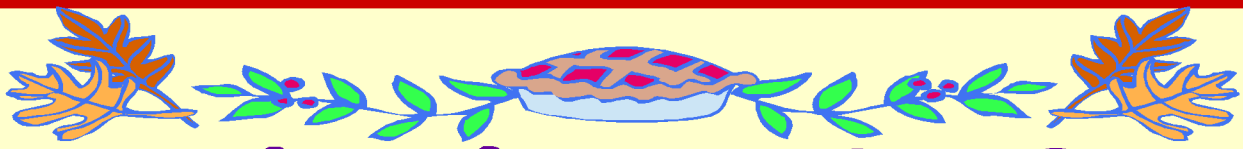

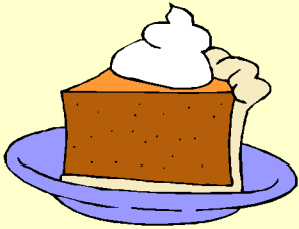




# The Breckenridge Fine Arts Center's BIG COUNTRY ART LEAGUE EXHIBIT

The Breckenridge Fine Arts Center would like to invite you to exhibit in its tribute to all artists who are members of an art guild, association, club, league, etc. The exhibit will be held from January 13th through February 21st, 2015. Details of the show include:

Eligibility: You must be a current member of an art guild or association and be 21 years of age or older. Artwork must not be older than 3 years and not previously shown at the BFAC. One to three pieces of art per member will be accepted. Keep in mind that artwork displayed at the BFAC will not be eligible for exhibiting in the Annual Juried Art Show in 2015.

Format and Media: Original, 2 and 3 dimensional art only. Oil, watercolor, scratch board, acrylic, gouache, tempera, mixed media, pastel, graphite/charcoal, pen and ink, bronze, pottery, wood and ceramic. This also includes photography and computer-generated artwork. All artwork should be framed or gallery wrapped and ready to hang. No sawtooth hangers accepted.

Entry Form: A completed entry form must be completed for each piece of artwork and should be sent/emailed to the BFAC no later than December 30,

2014. There is no fee for submission. If at all possible, please email an image of each piece of artwork for planning and advertising purposes. This can be sent to:

Deadline for art delivery: All artwork must be delivered to the BFAC no later January 5, 2015. No exceptions unless prior arrangements are made.

Sale of Artwork: The BFAC prefers entries that are for sale. Please state a price that reflects current market value for your artwork. For any artwork sold, the BFAC shall retain twenty-five (25%) of the

selling price as commission and shall remit seventy-five percent (75%) of the selling price to the artist.

Any "Not for Sale" entries should be marked "NFS," but include an insured value.

Close of Show: Artwork may be picked up on February 21st. If this is not possible, please notify the BFAC so we can make later arrangements for pickup.

Artist's Reception: An artist's reception will be held January 17th from 6 to 8pm.

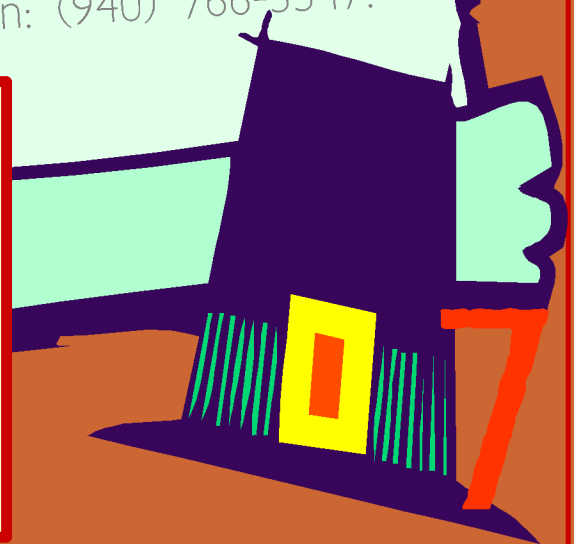






# 4th Annual Cowboy True Art Exhibit & Auction!
